

PRIVACY POLICY AND DISCLAIMER

JAMAICA-QUEENS WESLEYAN CHURCH

Our website and online services are owned and operated by the Jamaica-Queens Wesleyan Church (herein after known as JQWC) and hosted by Sharefaith, Inc. We are committed to protecting your personal information and your right to privacy. We hope that the following statements will help you to understand our policies and how we use the information that you provide to us. This privacy policy applies to all information collected through our website (www.JQWC.org), mobile application (Apps), and/or any related services, live-streaming, or events.

WHAT WE COLLECT AND HOW WE USE IT

We collect personal information such as name, address, contact information, passwords and security data, payment information and social media login data. We collect this information as voluntarily provided when you register on our Website (Site) or on our Mobile App (App), expressing an interest in obtaining information about us, our services, or while participating in activities such as posting messages on line, using our on line forms or otherwise contacting us. Some information like Internet Protocol addresses, browser and device characteristics are collected automatically, as well as your operating system, language preferences, referring URLs, country, location and cookies. Accepting our cookies allow us to maintain a user's preferences from session to session and to avoid repetition and redundancy. This information is used to maintain the security and operation of our site and contributes toward our internal analytics and reporting.

DO WE COLLECT INFORMATION FROM MINORS?

We do not knowingly solicit data from, or market to children under 18 years of age. By using our Site or Apps, you represent that you are at least 18, or that you are the parent or guardian of such a minor and consent to such minor dependent's use of our Site or App. There are forms provided on line at our Site for parents or guardians to grant permission for the JQWC website to use images of minors during special performances, events or live-streaming of our services. If we learn that personal information from users less than 18 years of age has been collected, we will deactivate the account and take reasonable measures to promptly delete such data from our records. If you should become aware of any data we have collected from children under age 18, please contact us.

OTHER SITES

This Privacy Policy applies only to the JQWC website and its mobile App that are owned and operated by the Jamaica-Queens Wesleyan church. Our church cannot regulate other sites linked from within our Site and App. These other sites may place their own cookies or other files on your computer, collect data or solicit personal information from you. You should familiarize yourself with their unique Privacy Policies, should you choose to visit their sites.

HOW DO WE USE YOUR INFORMATION?

When you sign up for a particular service that requires registration, we ask you to provide your personal information with your consent and/or for compliance with our legal obligations. We collect your information to support your participation, to deliver requested content, to note your preferences, and to keep you informed about events and related resources. Your email address and phone number will be occasionally used for Jamaica-Queens Wesleyan church communications you have opted-in to receive, including but not limited to email, SMS, MMS, text message or other reasonable means not known or later developed. We may use your information to assist us with data analysis, identifying usage trends,

determining the effectiveness of our promotional campaigns and to evaluate and improve our Site or App services and your experience.

We will never sell, share or spam your personal information, nor share it with other institutions outside of our church. However, JQWC may share your personal information if we have a good faith belief that access, use, preservation or disclosure of such information is reasonably necessary to

- (a) satisfy any applicable law, regulation, legal process or enforceable governmental request;
- (b) to enforce applicable Terms of Service, including investigation of potential violations;
- (c) detect, prevent, or otherwise address fraud, security or technical issues, or
- (d) protect against imminent harm to the rights, property or safety of JQWC, its users or the public as required or permitted by law.

You may opt out of electronically delivered communication at any time by using the “unsubscribe” feature for that service.

INFORMATION SECURITY

We aim to protect your personal information through a system of organizational and technical security measures, to protect against unauthorized access to or alteration, disclosure or destruction of data. Our website is hosted by Sharefaith, Inc., which adds another layer of protection. We guard against unauthorized access to systems where we store personal data by restricting access of personal information to only JQWC employees in our Audio-Visual section and contractors who need to have that information in order to operate, develop or improve our services. These individuals are bound by confidentiality obligations and threat of criminal prosecution. The Jamaica-Queens Wesleyan church however, is not responsible if unauthorized access to information does occur. We cannot guarantee that the internet itself is 100% secure. Although we may do our best to protect your personal information, transmission of personal information to and from our Site or App is at your own risk. You should only access the services within a secure environment.

DATA INTEGRITY

We review our data collection, storage and processing practices to ensure that we only collect, store and process the personal information needed to provide or improve our services. We take reasonable steps to ensure that the personal information we process is accurate, complete and current, but we depend on our users to update or correct their personal information whenever necessary.
